CONSENT JUDGMENT OF JUDGE B A CORKILL

[1] Part way through the hearing of a challenge to two determinations of the Employment Relations Authority,1 and a further matter which had been removed to this Court by order,2 the parties agreed to settle all matters between them on the basis that a consent judgment of the Court be issued.

[2] This judgment records the matters which the parties have agreed should be included in a consent judgment.

[3] Pursuant to [s 183\(2\)](#) of the [Employment Relations Act 2000](#) (the Act) and by consent, the determinations dated 20 October 2014 and 9 February 2015 are set aside.

[4] The terms of settlement between the parties are set out in a confidential settlement agreement, which I direct is now the subject of an order of non-publication pursuant to cl 12(2) of Sch 3 of the Act.

[5] There are no issues as to costs.
