CONSENT JUDGMENT OF JUDGE B A CORKILL

[1] The parties have agreed to settle all matters in dispute between them on the basis that a consent judgment of this Court be issued.

[2] Pursuant to [s 183\(2\)](#) of the [Employment Relations Act 2000](#) (the Act) and by consent, the determination of the Employment Relations Authority dated

20 November 2014 is set aside.¹

[3] The terms of settlement between the parties are set out in a confidential settlement agreement, which I direct is now the subject of an order of non-publication pursuant to cl 12(2) of sch 3 of the Act.
